Use equipment with 12 gauge extension cord; do not run ozone generator in occupied areas with persons, pets, plants and other ozone sensitive materials (example: some rubber may be effected by ozone), ensure room/area to be treated is properly sealed. After the ozone generator is shut off, air area before reenter.

1. Customer agrees to pay in full of all agreed rental costs upon delivery of equipment.
2. Customer agrees to return the equipment rented to Alpine Air Corp. in the same condition as it was received (no dust, debris in/out).
3. Customer agrees that No alterations or repairs may be made to the equipment by RENTER during the rental period.
4. Customer agrees that if the rented equipment is lost, or returned to Alpine Air Corp. in a damaged or dysfunctional state, beyond normal wear and tear, customer will pay full purchase price of equipment, or any amount to be determined by AAC, not to exceed purchase price of damaged equipment, plus all previously agreed upon rental fees. Such damage will include (but not be limited to) broken or missing parts and tools, disassembled or tampered with surfaces of the Rented Equipment, rendering the equipment unsuitable for further rental.
5. Customer agrees to hold Alpine Air Corp. harmless and absolve Alpine Air Corp. from any financial responsibility related to any property damage, Injury, illness, or death caused directly or indirectly by the use of any equipment rented from Alpine Air Corp.
6. Alpine Air Corp. does not provide machines for any jobs that involve hazardous materials such as asbestos or lead (call office for additional information).
7. Renter will call Alpine Air Corp. 1 (one) day before to schedule the pick-up for the rented equipment (this applies if AAC is responsible for pick-up the equipment).
8. End of rental term is the exact time of the day the equipment is received by customer. Additional time will be charged by hour unless stated otherwise in this agreement.

Additional rental equipment information

Certain jobs including but not limited to drywall compound sanding, wood sanding, cement/other-powder mixing, concrete/rock demolition, sand-blasting, painting, chemical/organic odor removal may result in heavy production of dust or particles and require a HEPA filter replacement. For these types of jobs, customer is obligated to replace primary filters and/or carbon filters as much as needed in order to keep the Air scrubber/Negative air Machines clean and avoid clogging the HEPA filter. Other machines such as Ozone Generators and Dehumidifiers may not be used during demolition or during other jobs in which production of dust particles may occur. All rented equipment/machines must be returned in pre-condition, wiped clean & and vacuumed free of dust/debris inside and out, otherwise a HEPA filter replacement and servicing charge may apply. For jobs where a HEPA filter replacement is required a servicing charge of \$195/per rented machine will apply in addition to regular Rental Agreement rates.

Please read the following carefully:

1. Customer agrees to return all rented equipment/machines in its pre-condition, wiped clean & and vacuumed free of dust/debris inside and out.
2. Customer agrees to use all primary filters (Stage one/two filters) initially purchased and contact office immediately should additional filters be needed, there are no returns of primary filters.
3. Customer agrees to provide own extension cord(s) for the equipment rented (unless specifically requested and indicated in blank spaces provided on Equipment Rental Agreement)
4. Customer agrees to verify with the Technician upon delivery the jobsite where the machines rented are to be used.
5. All filters that come with rented machines must be used and primary filters have to be replaced periodically while machines on site in any state.
Filters cannot be returned and no refunds are available for filters!
6. Alpine Air Corp is not responsible for setup or moving machines on site. Renter must have knowledge of how to operate and monitor rented equipment.
7. Renter is responsible for safety of jobsite and machines. Alpine Air Corp is not responsible if property damage occurs while running, transporting or during set-up of machines on site. Renter acknowledges that Alpine Air Corp. is only providing curbside delivery and does not perform any work.
8. By signing below, customer agrees to pay all agreed upon fees associated with the above stated addendum to rental agreement, and agrees to abide by all of the above statements.
